  - (d) your address is in the UK, Channel Islands or Isle of Man.
2. Only one £100 Cash Reward can be claimed per household.
3. To claim your £100 Cash Reward, you must send this claim form, properly completed, together with the originals of your final sales invoice, payment receipt and delivery note to the above address.
